# President's Budget Proposes Cuts to Funding That Supports Community Action

President Obama released his FY2013 budget proposal which uses a mix of spending cuts and tax increases to keep the

deficits lower, in accordance with the debt limit last passed last August. Overall the Administration's budget would spend about \$10 billion more than in FY2012, but also contained \$24 billion worth of cuts.

The Administration proposed \$350 million for FY2013 CSBG and expressed that they want this program to be made more competitive. LIHEAP received a cut of \$452 million with the proposed funding at \$3.02 billion, which the Administration justified by a decrease in energy costs nationwide. Weatherization also took a major cut with only \$135 million proposed by the Administration.
