ACAA 2012 Annual Conference Highlights

The ACAA 2012 Annual Conference was a great success and we are thankful to

all those who made it the wonderful event it was!

Thank you to our fabulous keynote speakers - Andrea Beaulieu, Lindsey Hodel, and Darick Simpson - who helped bring the theme of Building A Community of Action home!

For the first time ever, the Poverty Simulation was held in the Phoenix area, and it was incredibly well attended and well received. ACAA would like to thank the Yuma CAPs and our Poverty Simulation sponsor, APS, for making this event possible. In the words of a Poverty Simulation participant:

"This year I registered for Poverty Simulation which was a difficult but valuable experience.

As a 10-year-old boy with two siblings, "Mom" working a low-wage job, "Dad" being unemployed, and without adequate resources to get through the month, I had little power to effect any change. The stress was high, the parents were gone all the time, the teachers stayed distracted by the disruptive kids, and unsupervised kids were tempted with opportunities to commit crime. Community resources were available but limited and time-consuming to obtain.

While nothing is 'new' about these scenarios, in my 'real life' role as case manager with the older adult and disabled population, I don't often have the opportunity to work with the family as a whole. I do however often witness the impact of the stress extended family members in crisis have on many of my older adult clients.

The discussion after the simulation was enlightening and the real-world organizational changes that have resulted from this exercise demonstrate the power of the process. This experience renewed my commitment to reach out not only to my clients but through them however possible to try to reach that potentially unseen and unheard person connected to them. There's more I can do to educate, to encourage, to share resources, and to push back against the circumstances of poverty."

Arizona Public Service (APS) Crisis Bill Assistance Program Request for Proposal (RFP)

Next month, the Arizona Community Action Association (ACAA) will be issuing a state-wide RFP to recruit additional community partners who have the capacity to provide utility bill assistance in their communities to APS customers. Any non-profit corporation or public entity, including faith-based entities may apply for available funds. Providers will be contracted to provide utility bill assistance to individuals and/or families who are APS customers, and whose gross monthly income does not exceed 200% of the current Federal Poverty Guidelines. ACAA Now Accepting SNAP Partner Applications

ACAA is now accepting applications for non profit and faith or community based organizations who wish to become SNAP Partners for the FFY13 Partnership year (10/1/12 - 9/30/13).

Partners are eligible for a draw-down reimbursement of 40 cents for every dollar spent on allowable activities related to SNAP outreach, application assistance, and improving access to SNAP for households in need.

Wickenburg Receives Wellik Foundation Grant

The Wellik Foundation recently awarded Wickenburg Community Services Corporation (WCSC) with a grant of \$92,500 to be distributed among its member organizations, benefiting many in the local communities.

WCSC is the umbrella organization for a number of smaller, non-profit service groups including Wickenburg Ducks in a Row, Cops Who Care, the local St. Vincent de Paul, R&R Respite Center, the CAP office, and Saguaro Jane's in Wittmann. Each of these organizations, as well as WCSC itself, received a sizable portion of the grant.

"This is the second year the Foundation has given us a grant," said board member Charlie Petersen. "We have a very high appreciation for them, and I think they appreciate us too, for pulling all these smaller groups together under one umbrella and being able to help them all." Petersen was the author of the winning grant application.

The WCSC was founded by Mary Ackley in 1968. In addition to assisting other local charities, the organization supports two main annual events that benefit the community - the Back-to-School clothing event each summer, and food, health and hygiene item distribution in conjunction with Cops Who Care at Christmas.

**WACOG Foreclosure Prevention Workshop
June 9th, 2012**

The Western Arizona Council of Governments (WACOG) will host a free foreclosure prevention workshop for the Yuma County community in collaboration with the Office of Congressman Raul Grijalva, the Arizona Foreclosure Prevention Task Force and the Southwest Fair Housing Council. The event is on June 9, 2012 from 9 a.m. to 3 p.m. at the Yuma Main Library. While homeowners wait to speak to a counselor and/or lender, they will be given information on how to avoid loan modification scams and details of the Fair Housing Act. WACOG has invited housing counselors from Housing America, Comité de Bienestar, Campesinos Sin Fronteras and Catholic Community Services of Western Arizona to help. Additionally, some of the primary lenders in the area have confirmed their attendance, including Wells Fargo, Bank of America, GMAC and Chase. "Our strong partnerships and new collaborations are paving the way to make this event a success. We share one goal; to help people save their homes," Ryan concluded.
